EXECUTIVE DIRECTOR'S LETTER OF RESIGNATION.


14 years. It was September of 2006 that I was hired as the new Executive Director of the PLC. I thought then I would do it for a few years, and then maybe go back to being purely a homemaker. As time passed, I knew I was where I was supposed to be. I knew God had a plan, and that He would be using me to see it through. 14 years. Nothing happened quickly. When I started, we had \$9,000 to our name and the walk was over. Our biggest fundraiser for the year! There was work to be done. 14 years. Where do you begin when your vision for a ministry seems unattainable? Not enough room in the current location and ideas that seem too big for Van Wert. Well, you start with what's doable and for us that was prevention in the form of abstinence classes. After about six months of fundraising, we were able to establish PINK and Teen Support. The schools are loving our programs for the girls and want something for the boys. A little more fundraising and we establish BLUE. All around prevention is in place!

14 years. We now own the entire building we reside in. This.Is.Big! We have the space to go medical but not the funds. Is it attainable? The discussions begin...14 years. We decide to move forward with going medical. We assume fundraising will take a year or more. We were wrong! It took ONE banquet! Just one and we had the funds to transform our tiny office into a medical clinic. We decide to go big or go home! Not only will we do free pregnancy testing and ultrasounds, but we want to establish total sexual health care for our patients so we implement STI Testing too. After a lot of stress, some tears, and a lot of hard work, we accomplish what we once thought would never happen. 14 years. We have now been operating as a medical clinic for a few years. What I set out to do from the beginning is in place. It was all in God's timing, as is everything in life. Therefore, I have no doubt that as we enter this new phase, it's all part of God's timing and plan too, and that He knows better than any of us! 14 years.

For many years, I have struggled with autoimmune diseases. Some days were better than others, but I was always able to push through. However, a year ago, I was struck with a major flare up which has left me sidelined and working from home. As I continue to try to adjust to my body's new normal and the new treatments I receive, I'm also faced with the unfortunate fact that I am considered high risk for severe Covid. All of that put together continues to keep me working from home. It's never easy for a ministry to function and move forward when the Executive Director can't be present. No matter what I do from home, it can't replace having a presence at the office and in the community. For this reason, **it is with a heavy heart that I am announcing my resignation.**

I believe God used me for 14 years to accomplish what He needed from me, and now He will use someone else to further the work of this ministry. I know His hand of favor has been upon the PLC and always will be. I do intend to continue with my duties as Executive Director until the end of the year with the new director taking over January 1st 2021. Thank you for trusting me to lead this ministry over the years. Thank you for allowing me to dream big, follow God's will, and even mess up sometimes! I am well aware that any of the successes the PLC has seen are due first of all to God and secondly to all of our faithful supporters who have always believed in this ministry. I hope you continue to pray, give, and support. A change in leadership does not change our direction- His will be done!
